Call to Order

Following dinner, the governing body relocated to the Bulldog Board Room to conduct their regular monthly meeting.

Vice-Chairman Todd McGraw called the meeting to order at 7:00 p.m. and Trustee Aldama said a prayer before the meeting began.

Board Announcements

No announcements were made.

Open Forum Time

Mr. Chris Woosley with Corsicana City Council requested to speak to the Board. Mr. Woosley spoke regarding property tax rates which are concerning; presented CAFR data and property tax rate showing property tax levy percent over the past 10 years and how it has increased, then asked Navarro College Board to consider setting the property tax rate to zero. Mr. Woosley stated that in general Navarro College has done a good job of reducing its debt.

Trustee Boyd made a motion to approve the Consent Calendar and was seconded by Trustee Atkeisson. All in favor / none opposed.

Update on Enrollment

Dr. Fegan presented the enrollment update in Vice President Sina Ruiz absence. Summer II 2023 enrollment semester credit hours were down by 146 or 1.74%, Fall 2023 down by 1,097 hours or 2.8% compared to this time last year.

Summary of the pre-registration traffic enrollment as of July 26, 2023 compared to the same time last year:

- Summer II down in semester credit hours by 146 or 1.74%, enrollment up by 23 or 1.38%, and contact hours up by 522 or 0.27%. Enrollment and Contact Hours were up due to football program starting early.
- Fall 2023 down in semester credit hours by 1,097 or 2.8%, down 160 or 3.61% in enrollment and down 23,436 or 2.75% in contact hours

Consider Action on June 2023 Financial Statement

Vice President Teresa Thomas presented June 2023 Financial Statement for approval.

- Budget amendments for June 2023 totaled \$657,681 of which \$649,895 were moved from fund balance to repair the parking
 lots in Corsicana and Waxahachie, \$3,202 was to increase the budget for the NC Foundation award to Biology for Teaching
 Innovation Award: and \$4,584 was moved from lost revenue for seating at the Beautique
- Source of funds as of June 2023 the college has received 84.3% of the Academic student income, 102.3% of Continuing Education student income, 111.6% of local appropriations, and 72.4% of total general operating and grant budgets.
- Year to date expenses for the education and general fund are lower than June 2022 by \$5,235,445. State, Federal, and Local grants were \$11,391,349 lower than June 2022 due to HEERF funds being almost completed. Other expenditures increased in total from the same time last year by \$6,155,904. Fund balance appropriations of \$5,125,989 and lost revenue appropriations of \$2,493,129 account for increases in expenditures during 2023. These include \$100,000 to TASB, \$81,560 for CEI, \$469,191 to Oracle, \$2,310,203 for Turf, \$1,219,490 taken from fund balance for IT budget, \$182,000 for police cars, \$649,895 for parking lots, \$45,000 for storage containers, \$68,650 for iron fence for turf field, and \$2,493,129 of lost revenue for equipment and various construction projects.
- The comparative summary for sources and disbursements as of June 2023 are Educational & General Revenue before HEERF federal dollars higher by \$1,527,967 from the same time in June 2022. Educational and General resource allocations before HEERF federal grants increased by \$6,769,261 and the auxiliary net income decreased \$2,910,077 from this same time in June 2022. In the General operating fund, \$626,877 of the increase was for our appropriations to the debt service fund to pay for bonds in November 2022 and appropriation was made for the entire year in November. Also, payroll increases and projects using lost revenue and fund balance in both general operating and auxiliary funds also are reasons for the increases in expenses and decreases in net income from 2022 to 2023.
- Comparison of the year-to-date revenue budget (amended budget) for June 2023 to the actual month to date revenue for June 2023 shows we still have \$14,735,533 of revenue to collect, however, over \$6 million is in the budget for appropriations from fund balance and lost revenue and that is not in actual dollars because they were collected in previous years. Contingencies total \$505,773 of additional tax revenue and \$198,431 of salary contingencies.

Trustee Aldama asked about how long the HEERF funds will be shown on financials.

Dr. Fegan explained that the HEERF funds will be shown on the financials until at least March of 2024.

Trustee Seely made a motion to approve the June 2023 Financial Statement and was seconded by Trustee Wyatt. All in favor / none opposed.
